## **PRIVACY POLICY**

At Finanz Butik, protecting your private information is our priority. This Privacy Policy describes the types of information we may collect from you or that you may provide when you visit [www.FinanzButik.com](http://www.FinanzButik.com) (our “**Website**”), and our practices for collecting, using, maintaining, protecting and disclosing such information. Unless otherwise specified, the terms “**Finanz Butik**,” “**we**,” or “**us**” refer to Finanz Butik LLC. Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. By using the Website, you consent to the data practices described in this Privacy Policy.

### **Information We Collect About You and How We Collect It**

We collect several types of information from and about users of our Website, including information:

- by which you may be personally identified, located or contacted, such as first and last name, mailing address, email address, phone numbers, or any other identifier by which you may be contacted online or offline (“**Personal Information**”);
- that is about you but individually does not identify you; and/or
- about your internet connection, the equipment you use to access our Website and usage details.

We collect this information:

- directly from you when you provide it to us;
- automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses, browser type, domain names, access times, referring website addresses and information collected through cookies, web beacons, and other tracking technologies; and/or
- from third parties, for example, our business partners.

### **Children Under the Age of Sixteen**

Our Website is not intended for children under 16 years of age. No one under age 16 may provide any Personal Information to or on the Website. We do not knowingly collect Personal Information from children under the age of 16. If you are under the age of 16, do not use or provide any information on this Website, or through any of its features, register on the Website, or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or user name you may use. If we learn we have collected or received Personal Information from a child under 16 without verification of parental consent, we will delete that information. ### **Information You Provide to Us**

Other than the automatic data collection described below, we do not collect any Personal Information about you unless you voluntarily provide it to us. However, you may be required to provide certain Personal Information to us when you elect to use certain products or services. These may include:

- registering for an account, subscribing to our service, or requesting further services;
- entering a sweepstakes or contest sponsored by us or one of our partners;
- signing up for special offers from selected third parties;
- sending us an email message;
- submitting your credit card or other payment information when ordering and purchasing products and services.

To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather Personal Information and other information about you in the future.

### **Information We Collect Through Automatic Data Collection Technologies**

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns. The information we collect automatically may include Personal Information or we may maintain it or associate it with Personal Information we collect in other ways or receive from third parties. This helps us to improve our Website and to deliver a better and more personalized service.

We may keep track of the websites and pages you visit within our Website, in order to determine what services are the most popular. This data is used to deliver customized content and advertising within our Website to customers whose behavior indicates that they are interested in a particular subject area.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Finanz Butik pages, or register with Finanz Butik site or services, a cookie helps Finanz Butik to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Finanz Butik website, the information you previously provided can be retrieved, so you can easily use the Finanz Butik features that you customized.

You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Finanz Butik services or websites you visit.

- **Flash Cookies.** Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies.
- **Web Beacons.** Pages of our Website and our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit us, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

### **How We Use Your Information**

We use information that we collect about you or that you provide to us, including any Personal Information:

- To present our Website and its contents to you.
- To provide you with information, products, or services that you request from us.
- To fulfill any other purpose for which you provide it.
- To provide you with notices about your account.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us.
- To notify you about changes to our Website or any products or services we offer or provide though it.
- To allow you to participate in interactive features on our Website.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.

We do not sell, rent or lease your Personal Information to third party marketers, research organizations, or other third-parties that are not affiliated with Finanz Butik.

## **Disclosure of Your Information**

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose Personal Information that we collect or you provide as described in this Privacy Policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business.
- To provide appropriate levels of service during and following completion of a transaction, such as repairs, maintenance/correction of deficiencies, warranty coverage, and the provision of telecommunications, utility and similar services.
- To trusted partners to help perform statistical analyses, send you email or postal mail, provide customer support, or arrange for deliveries. Such trusted partners are required to maintain the confidentiality of your information and are prohibited from using your Personal Information except to provide these services to Finanz Butik.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Finanz Butik's company's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by Finanz Butik about our Website users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your Personal Information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our website terms and conditions and other agreements.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Finanz Butik, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

We strive to provide you with choices regarding the Personal Information you provide to us.

We do not control third parties' collection or use of your information to serve interest-based advertising. When payment transactions are transmitted to other websites, related information such as credit card numbers are protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your Personal Information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Website cannot be guaranteed.

### **Personal Information Rights (Deletion, Information, Correction)**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your Personal Information from our records;
- Direct any service providers to delete your Personal Information from their records;
- Disclose to you what Personal Information has been collected, used or shared about you, and why it was collected, used or shared; and
- Correct inaccurate information that we may have about you.

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or

- Otherwise use your Personal Information, internally, in a lawful manner that is compatible with the context in which you provided the information.
